



# **Agency History**

The South Carolina Legislature restructured a significant portion of state government in 1993. Effective February 1, 1994, Act 181 created the South Carolina Department of Labor, Licensing and Regulation (LLR). This legislation merged the Department of Labor, State Fire Marshal's Office, the South Carolina Fire Academy and 38 professional and occupational licensing boards to form the new agency.

The legislation empowered the Governor to appoint a director of the agency with the advice and consent of the Senate.

LLR is organized into four divisions: Fire and Life Safety, Labor, Professional and Occupational Licensing and Administration.



# **Mission Statement**

# Making South Carolina a Safer and Better Place to Work and Live

The South Carolina Department of Labor, Licensing and Regulation will accomplish its mission by:

- Promoting a regulatory climate that provides a safe and healthy environment where businesses can be successful in a manner that benefits our citizens;
- Conducting appropriate inspection and complaint investigation programs and, when necessary, pursuing enforcement options as provided by law;
- Administering licensing, permitting and certification programs, as provided by law; and
- Providing appropriate education, information, and outreach programs.

# Accomplishments 2000-01

# **Division of Fire and Life Safety**

## Office of State Fire Marshal

- Conducted seven State Fire Marshal certification courses across the state.
- Entered into the third year of a three-year grant with the South Carolina Department of Health and Environmental Control to conduct fire safety education programs which provided smoke alarm installations in Charleston, Chesterfield, Fairfield, Marlboro, Orangeburg and Williamsburg counties.
- Presented a two-day workshop for fire safety educators conveying basic knowledge and skills necessary to effectively deliver safety and survival behavioral messages.
- Conducted two-day grant writing workshop for fire service and public administrators.
- Partnered with the S.C. Department of Education to provide fire safety curriculum to special needs children.
- Conducted/hosted the Mid Atlantic Association of State Fire Commissions Conference.
- Expanded Freddie Fire Safety Curriculum distribution from 245,000 students the previous year to 285,000 students.
- Conducted specialized training on the National Fire Incident Reporting System during a two-day workshop.
- Developed smoke alarm installation and educational program with the Department of Disabilities and Special Needs to reach high-risk families.
- Distributed approximately 70 computers marked for surplus property to encourage participation in the State Fire Incident Reporting System.
- Attended training classes, which included code changes, legal requirements, customer relations and handling of LP gas.
- Expanded engineering staff's role in educating designers, contractors and local officials about fire protection requirements and methods.
- Developed a resource library, housing videos and materials to assist with fire safety education.

## The South Carolina Fire Academy

- Provided 35 instructor recertification workshops for 298 instructors and conducted three instructor update programs for 38 students.
- Conducted 21 Aircraft Rescue Firefighting classes with 146 students includling 68 firefighters from across the country trained in the 48-hour IFSAC Certification Course Basic Aircraft Rescue Firefighting.
- Conducted 12 Instructor Methodology Courses with 145 students.
- Conducted one Chief Fire Officer seminar for students.
- Conducted one Fire Officer Symposium for students.
- Co-hosted the annual Instructors' Improvement Conference at the Fire Academy in partnership with the S.C. Society of Fire Service Instructors.
- Conducted four seven-week Firefighter II programs, which is an IFSAC-accredited program that meets the NFPA 1001 Standard for Firefighter II.
- Conducted the annual Southeastern Weekend Fire School.
- Conducted 1,273 programs for municipal departments, reaching 15,659 students for 381,663 student hours; and 164 industrial programs reaching 2,419 students for 39,409 instructor hours. This was a total of 1,437 programs reaching 18,048 students for 421,072 contact hours.

# **Division of Labor**

- The Office of OSHA Voluntary Programs established a goal of increasing the number of annual consultative visits to businesses by 25 percent in fiscal year 2001. Hazards identified and corrected totaled 9,521. In fiscal year 2001, OVP consultants saved South Carolina businesses \$5 million in OSHA fines.
- South Carolina continued to lead the nation with the most VPP Star sites in any state plan state. The Office of OSHA Voluntary Programs continued to offer regional training programs and on-site consultations free-of-charge to employers across the state.

- The Office of Labor Services continued to educate the public through mail outs, personal contacts and speaking engagements throughout the year. News conferences were held in Greenville with both print and TV media to discuss child labor laws and requirements to further educate the employers of their responsibilities. The office changed the territory of the investigators to better utilize personnel.
- The Office of Labor Services reclassified an administrative assistant to an Intake Officer. The intake officer took complaints related to wages and child labor issues statewide. This officer is available through a toll-free number from 8:30 a.m. to 5 p.m. Monday through Friday.
- The Office of Labor Services investigated 100 percent of all complaints received.
- The Office of Labor Services worked to fairly resolve a significant amount of disputed citations with employers to avoid expensive litigation procedures.
- The Office of Labor Services updated its Web page to include a complaint form and instructions, and posted questions and answers to frequently asked questions.
- The OSHA Compliance Section continued its policy not to issue citations for other-than-serious violations corrected during an inspection. This resulted in the immediate abatement of 3,126 violations. The Compliance Section continued to give an additional 15 percent penalty reduction for immediate abatement of serious hazards.
- The Office of Elevators and Amusement Rides produced an amusement ride safety coloring book for children that was distributed at the State Fair in Columbia.
- The Labor-Management Mediation Office is strengthening its relationship with the Federal Mediation and Conciliation Service to offer better service. The office continues to communicate with employer and union representatives on a pro-active basis during negotiations to offer suggestions and assistance to keep work stoppages to a minimum.
- The Migrant and Seasonal Farm Workers Commission continued to distribute to growers, workers, agencies and organizations the video package "Steps to Compliance An Educational Tool for Growers in South Carolina" and "Avoiding Immigration Discrimination in Agriculture." The Commission continues to work with the State Housing Authority and Design Corps on obtaining a HOME grant for migrant housing. Many seminars on housing were sponsored. The Commission continues to update and distribute "South Carolina Migrant Services," a handbook available in English and Spanish.

# **Division of Professional and Occupational Licensing (POL)**

- Instituted procedures to ensure employees are available at all times to answer customer inquiries.
- Purchased a new data management system to unify the licensing process for all boards. The system has already been implemented for one board with 12 others scheduled for implementation by the end of the calendar year. The system will provide for:
  - Improved reporting capabilities
  - Internet license renewals
  - Improved office and division-wide data collection, searches and information
  - Simplification of the licensing process for all boards
- The Division and the Office of Public Information continued to produce "Career Close-Up" pages for newspapers throughout the state. Each week, a profession or occupation was highlighted and interested students interviewed. Information provided, at a minimum, included education requirements, venues of practice, salary prospects and licensing information.
- Employees at all levels participated in developing the division's strategic plan.
- Developed and implemented, with the Office of Information Services, intranet upgrades which provide for greater management access to and dissemination of information by management level staff.
- Participated in the successful online renewal pilot project with the Office of Information Resources.
- Developed new board Web site format, providing lcensees and the general public easier access to licensing and agency information and reducing staff time required to respond to routine inquiries.
- Established guidelines, which provide for greater uniformity in the disciplinary process.
- Redefined and updated revenue codes to provide for greater accuracy of management/financial reporting. New coding structure provides for sub-categories of licenses to ensure duplication of information is reduced.
- Provided training and policy manual to board members.
- Developed a licensing orientation program for new and potential licensees.

- Provided speakers and trainers to schools, colleges, professional associations and others.
- Researched systems to reduce amount of paper use for required board functions. This will be implemented during the 2001 calendar year.
- Developed and implemented a system to reduce amount of pwper used in the building codes approval process. This system is the first of its kind in the nation.
- Received a national award for a real estate training program.
- Revised several practice acts to bring them in to conformance with the division's "Engine" legislation which provides policy and procedural context for all licensing boards under the LLR umbrella.
- The Cosmetology Board successfully established and offered instate/inactive license status to licensees.
- The Board of Dentistry served as liaison to Southern Regional Testing Agency, Inc. (SRTA), which administers clinical dental and dental hygiene examinations to ensure that only practitioners meeting state-established requirements were licensed and practicing.
- The Board of Nursing successfully participated in an online license renewal pilot project.
- The Board of Nursing was one of seven nursing boards nationwide selected by Citizens Advocacy Center, Washington, DC, to participate in pilot project PREP (Practitioner Remediation Enhancement Project).
- The Board of Nursing administrator was chosen to represent the National Council of State Boards of Nursing at National Landmark Conference on Nursing Shortage in Edmonton, Alberta, Canada.
- The Board of Nursing's manager of Regulatory/Compliance was chosen to organize and conduct an investigators summit on Elderly Abuse in at the National Council of State Boards of Nursing in Chicago.
- The Board of Nursing assisted in the funding of Colleagues in Caring grant (through Robert Woods Johnson Foundation) for Nursing Workforce Development in South Carolina.
- The Board of Occupational Therapy's administrator presented a program on the utilization of Web sites by state regulatory agencies.
- The Board of Occupational Theraphy's chairman and other board members presented an educational program at the annual meeting of the South Carolina Occupational Therapy Association (SCOTA)
- The Board of Optometry provided mail outs to inform the public and licensees of four issues: Cosmetic Contact Lens Abuse, SilverRx Card Program, Continuing Education Requirements, and Vehicle Window Tinting.
- The Board of Optometry accepted COPE for help in identifying continuing education approval.
- The Board of Opticianry members and administrator participated in national and local meetings.
- The Board of Opticianry administrator participated in national practical examination development discussion for examination in Opticianry.
- The Board of Opticianry adopted an Opticianry Code of Ethics for Opticians in South Carolina.
- The Board of Opticianry provided mail outs to inform the public and licensees of four issues: Cosmetic Contact Lens Abuse, SilverRx Card Program, Continuing Education Requirements, and Vehicle Window Tinting.
- The Board of Opticianry hosted a national meeting on the development of a national practical examination.
- The Board of Professional Counselors, Marital and Family Therapists, and Psycho-Educational Specialists published *NEWSFLASH* newsletter; and revised "In A Nutshell" summary of licensure procedures.
- The Board of Professional Counselors, Marital and Family Therapists, and Psycho-Educational Specialists sponsored the South Carolina Educators' Meeting for Higher Education Degrees for Licensure.
- The Board of Professional Counselors, Marital and Family Therapists, and Psycho-Educational Specialists approved acceptance of NCE and NDMHCE examinations for licensure.
- The Board of Architectural Examiners co-sponsored a one-day workshop for building officials statewide. Co-sponsoring the workshop decreased Board costs.
- The Board of Architectural Examiners created an electronic log of complaints received; revised procedures for opening complaints to more accurately capture data and to ensure consistency in handling.

# Administration

- Developed and completed the Request for Proposals (RFP) for a consolidated licensing system.
- Since January 1, 2001, LLR's Web site has accumulated 5,496,848 hits, making it one of the most visited sites in South Carolina state government.
- Converted numerous work forms to word processing templates. This conversion also has allowed LLR to place more than 100 forms on the agency Web site for downloading by the public.
- Placed licensee verifications on the agency's Web site. Tens of thousands of previously mailed verification requests are now handled electronically without intervention of agency staff. The Board of Medical Examiners had more than 40,000 Web site requests for physician license verifications in May 2001. Agencywide, online verifications tripled over the past year.
- Director Rita McKinney met with 284 of the agency's employees during this year to better understand employee concerns and needs.
- The exit interview process was examined, and a new questionnaire was developed and utilized. The results are shared quarterly with the Leadership Team, which uses the data to implement changes.
- A new orientation program was developed and delivered to every agency employee and will be used for all new employees. The orientation program focuses on the agency's strategic plan with a primary focus on customer service. With agency expectations stated clearly upon arrival, employees are clear as to agency expectations.
- Agency supervisors completed 100 percent of their performance evaluations in a timely manner.
- The Leadership Team hosted an employee appreciation day luncheon for all agency employees.
- The agency's turnover rate decreased from 8.15 percent in fiscal year 2000 to 5.67 percent in fiscal year 2001.
- Conducted the following on-site programs for employees: blood drives; mammogram van visit; health/ benefits fair; pre-retirement planning seminar; and employee health preventative brown bag lunches.
- Established Dial-A-Job telephone line for easy access to vacancy information.
- Exceeded Minority Business Utilization plan goals by 56 percent.

# **Public Information**

- Along with the OSHA Office of Voluntary Programs, implemented year two of a statewide media campaign on worker safety called "SafetyWorks!"
- Continued a statewide media campaign to reduce fire deaths under the slogan, "Survivor or Statistic. Get Fire Smart." The campaign included a TV public service announcement, bumper stickers and brochures with fire safety messages. The Office, along with South Carolina Educational Television, was a finalist for an emmy for the campaign's PSAs.
- For the third consecutive year, the office earned a first-place award in the newsletter category of the South Carolina Press Association's annual awards. The award was for *LLR Times*. The office placed third in the same category for "Fire and Life Safety News." The office also received a third-place award for its Web site.
- Earned a Certificate of Merit through the South Carolina Chapter of the Public Relations Society of America for the Career Close-Up pages, which appear in newspapers across the state to help increase students' awareness of career possibilities.
- The office, along with POL, continued to produce "Career Close-Up" pages for newspapers throughout the state. Each week, a profession or occupation was highlighted and interested students interviewed. Information provided, at a minimum, included education requirements, venues of practice, salary prospects and licensing information.
- Produced new brochures, newsletters and other educational materials about agency programs, boards and offices.
- Redesigned and continued to expand information available to the public through the agency's homepage on the Internet.
- Began the first phase of creating a strategy to enhance the agency's profile.
- Held several news conferences on issues affecting the agency.

# DIVISION OF FIRE AND LIFE SAFETY

The Division of Fire and Life Safety serves as the fire safety focal point for South Carolina, maintaining a statewide delivery system for fire prevention, protection and training services. The division provides leadership, guidance and services needed by the fire service to carry out its responsibilities at the local level. The Office of State Fire Marshal and the S.C. Fire Academy comprise the division.

# **Responsibilities**

Statutory responsibilities for the primary programs of the division are as follows:

Code Enforcement (23-9-10 through 23-9-180):

Charges the State Fire Marshal with responsibilities for requiring compliance with national and state-adopted fire safety codes and standards promulgated by the Division of Fire and Life Safety and the Liquefied Petroleum Gas Board and gives authority to the State Fire Marshal to inspect buildings for codes compliance.

South Carolina Fire Academy (23-10-10):

Charges the Fire Academy with the operation of a training facility to upgrade the state's fire service personnel—paid, volunteer and industrial.

# **Office of State Fire Marshal**

# **Programs**

The Office of State Fire Marshal has regulatory responsibility to ensure compliance with state fire safety regulations. This is accomplished through inspection activities by deputy state fire marshals in the field, code consultation and plans review services provided by the Engineering Services Section. Fire prevention activities aimed at reducing the state's fire death rate are managed by the Public Fire Safety Education Section. Activities include the distribution of smoke alarms, programs in the schools to educate youth and the dissemination of timely fire safety information to the public.

# **Public Fire Safety Education**

## "Get Alarmed, South Carolina"

The "Get Alarmed, South Carolina" program is an on-going public fire safety awareness campaign where the main objective is to lower fire deaths by 1) alarming citizens about the fire problem and teaching them about fire safety, and 2) providing smoke alarms to high risk citizens—the elderly, economically depressed and handicapped. Forty-six county coordinators serve as liaisons to assist in distributing materials and smoke alarms for this program.

## School-Based Public Fire Education Curriculum

The "Freddie the Fire Cat" curriculum is a comprehensive fire safety educational curriculum for students in kindergarten through fifth grade. "Freddie's Fire Smart Kids" is a curriculum for kindergarten and first grades. "Freddie's Fire Safety Friends" is an expanded curriculum for second and third grades. During the fall of 1998,

the fourth- and fifth-grade curriculum, "Freddie Gets Fired Up," was piloted and was introduced into the school system during the fall of 1999. To date, more than 285,000 students (out of a possible 299,000) in kindergarten through fifth grade have received vital fire safety and survival education through these programs. Each curriculum contains lesson plans, student activity workbooks, graduation certificates, a video to coincide with each lesson plan and a storybook introducing "Freddie" and his life story. A video has been produced to accomplish in-service training for teachers to acquaint them with the "Freddie" curriculum.

"Freddie the Fire Safety Cat" is the Office of State Fire Marshal's mascot and is used at various functions by schools, civic groups, churches, government agencies, fire departments, etc. "Freddie," along with educational materials, provides children and adults with a powerful message of being fire safe. The office has two "Freddie" mascot suits.

#### Fire Incident Reporting

State law requires the division to collect and analyze data on fire incidents. The division does this through a comprehensive National Fire Incident Reporting System (NFIRS) created for fire departments in South Carolina. This system provides accessibility to data and reports which help departments focus on current problems, predict future problems in their communities and measure whether their programs are working. At a broader level, this information aids the state through work with the legislature. NFIRS has been used to justify the state budget and has helped in the passage of important bills on smoke alarms. It also enables the division to provide more accurate statistical information to the national level.

A software package can be obtained from the Office of State Fire Marshal that takes the place of departments sending in fire incident forms. By entering their own reports, the departments can extract statistics to identify their fire problems. The Office of State Fire Marshal trains the departments to use the software and provides troubleshooting as needed. Training is also provided on the fire incident forms. Seventy computers have been distributed to fire departments.

A document describing the fire statistics collected is compiled and printed in a handbook that is distributed to fire departments across the state.

#### Fire Death Reports

When a fire death occurs in South Carolina, a fire fatality form is filled out by a deputy state fire marshal, a fire chief or a coroner. Once this form is completed, it is returned to the Office of State Fire Marshal and added into a database. These statistics are analyzed at the end of each month to give the total number of fire deaths for the month and for the year to include death by county, cause of death, smoke alarm presence, structure death occurred in and age of the deceased. These statistics are used statewide by the media, fire departments, fire organizations, government agencies, etc.

#### Fire Safety Materials for Distribution

The office receives many requests for public fire education materials. Coloring books, flyers on smoke alarm maintenance, general fire safety booklets, pencils and stickers are some of the materials sent to fire departments, government agencies, schools, etc. In addition, the office serves as a resource to local fire departments by maintaining a resource center housing videos on various fire safety subjects. They are available on a check-out basis.

#### **Programs and Presentations**

Various presentations are given on fire safety throughout the year. The S.C. Department of Disabilities and Special Needs, Carolina Health Care and S.C. Department of Health and Environmental Control's Division of Women and Children's Services are some of the agencies receiving continuous training. In addition to presentations, many programs have been established by partnering with DHEC, such as the "Save Our Children" program, a sub-program of "Get Alarmed South Carolina."

When home health care nurses discover a home without a smoke detector, they call the county coordinator for their area to schedule a visit to the home. Nurses are taught to conduct home fire safety inspections, and this becomes part of their routine survey.

The S.C. Department of Disabilities and Special Needs contracts with the Office of State Fire Marshal to provide four annual training sessions on fire safety to its staff. The office also trains its staff to provide home fire safety inspections and to install smoke alarms when needed.

The Office of State Fire Marshal also makes presentations and provides displays at annual meetings of state associations including the S.C. State Firemen's Association, S.C. State Association of Fire Chiefs and S.C. Fire Inspectors' Association.

A partnership with the S.C. Safe Kids Coalition enables the development and distribution of a safety calendar to 13,000 elementary classrooms, pediatric offices and day care facilities.

#### **News Releases**

Monthly news releases are generated to inform the public on fire education issues such as heating safety and smoke detector distribution. The releases are sent to newspapers and TV and radio stations. Heating safety, holiday safety, dormitory safety and Fire Prevention Week activities are among recent news releases distributed.

#### Fire Prevention Week and State Fair

The Office of State Fire Marshal coordinates statewide Fire Prevention Week campaigns focusing on a specific fire safety topic. The fire service is often involved in activities such as holding exit drills within their communities simultaneously. The office serves as a resource to the general public and the fire service for fire safety materials and presentations.

#### **Burn Camp**

The Office of State Fire Marshal has participated in the Children's Burn Camp of Florida at Walt Disney World since 1995. South Carolina sends burn survivors (children) and buddies. These children are recommended through hospitals and organizations dealing with burned children. The participants are entertained throughout the weekend with no expense to the families. A visit to a major theme park is the highlight of the weekend. Private individuals, fire service organizations and corporations contribute to this cause.

#### **Special Projects**

The office participates in several special events each year including the S.C. SAFE KIDS teleconference. South Carolina also has participated in special studies conducted by FEMA to look at community-based fire education and received a grant to implement such programs. In another study conducted by USFA, South Carolina was identified as one of four states leading the way with effective fire education programs. Partnering with DHEC, a \$150,000 grant dealing with residential fire safety and the installation of smoke alarms was awarded by the Center for Disease Control.

# **Field Services**

The Field Services staff continued to work to improve its inspection skills and overall employee skills. This was done by attending periodic training classes including proper handling of LP Gas, code changes, legal requirements and customer relations.

The deputies were also encouraged to participate in a wide range of other professional association activities, such as attending their county fire chiefs' association and other fire service organizations. They were encouraged to keep these organizations abreast of changes in code and regulations as they occurred.

The staff continues to work to improve the delivery of services to our customers.

# **Engineering Services**

#### **Plans Reviews**

The engineering staff provides comprehensive reviews of building designs and building systems to determine compliance with state laws, regulations and codes. These may be plans of state buildings, which are referred by the state engineer's office, day care centers referred by the Department of Social Services (DSS), local prisons referred by the South Carolina Department of Corrections, building plans referred by local jurisdictions, and others as required by state law. This service can identify unsafe designs before the building is constructed, resulting in less expensive and often more effective code compliance. The staff's efforts to improve and streamline the review process with fewer delays for the "customer" (owners, designers, contractors) continues. In FY 2000-2001, 517 projects were reviewed, representing almost 150 million square feet of building space.

#### **Technical Assistance**

The staff provides technical assistance to owners, designers, contractors and private citizens, as well as state and local government officials. This assistance is provided through phone conversations, meetings, on-site visits and letters. The type of assistance ranges from simple questions on requirements, to large and difficult fire protection engineering problems that are not specifically addressed by codes. The office maintains a comprehensive and up-to-date reference library for research into the latest opinions and methods of fire protection design. The staff also maintains working relationships with regional and national fire protection organizations. This information base, coupled with a trained staff specializing in all aspects of fire and life safety design, is a resource that is not available anywhere else in South Carolina.

#### Education

In FY 2000-2001, the engineering staff continued to expand its role in educating designers, contractors and local officials about fire protection requirements and methods. The staff conducted presentations at seminars and professional association meetings, taught courses and published newsletter articles.

# **South Carolina Fire Academy**

The Fire Academy's mission is to develop an instructional delivery system through which a standardized, statewide firefighter training curriculum is developed and implemented to train a maximum number of career, volunteer and industrial fire service personnel. Services are provided to accomplish the following activities: developing the skills necessary to command and control emergency operations involving fire, rescue and hazardous materials incidents; developing the managerial and leadership skills for all levels of fire service officers; and developing skills in fire department support functions to include public fire education, fire prevention inspections and investigations.

The Fire Academy has three separate program areas: Resident Training; Regional Training; and Curriculum, Instructor Certification and Accreditation. South Carolina has an estimated 800 fire departments with 18,000 paid and volunteer firefighters. Last year, the Fire Academy trained 15,659 public fire service and emergency personnel and 2,419 industrial fire brigade members.

#### **Resident Training**

The Fire Academy has been in operation at its present site since July 1995. This premier state fire-training Fire Academy features modern classrooms, a 60-room dormitory, cafeteria, drill tower, six-bay fire station, student processing center, two burn buildings, flammable liquid and gases training, propane live-fire training, and two computer-controlled Federal Aviation Agency-funded aircraft training props. Many specialized programs that require live burns are conducted at the Fire Academy site. Also, many industrial customers come to the Fire Academy for their emergency training. Last year, the Fire Academy conducted 164 industrial programs with 2,419 students attending. Industrial customers are both in-state and out-of-state companies. They pay a reasonable fee for this training, and the revenue helps operate the Fire Academy. Industrial revenue is about 33 percent of the Fire Academy budget. The Fire Academy also conducts haz-mat and rescue programs for the S.C. Emergency Preparedness Division, funded by Federal Emergency Management Agency (FEMA) grants. The Fire Academy received an \$80,000 grant from FEMA and the National Fire Academy to conduct specialized terrorism and rescue programs and to purchase equipment, books and materials to support these programs. The Fire Academy also received a \$30,000 grant from FEMA for Incident Command type training.

#### Curriculum, Accreditation and Certification

The Fire Academy maintains an instructor certification program for more than 640 part-time instructors, who teach courses at the Fire Academy and in their local fire departments. The instructor certification system involves establishing requirements for entry-level instructors and the recertification of our existing instructors. The instructor certification system is a vital part of the Fire Academy off-campus training. This past year, the Curriculum Section saw the full implementation of the three new programs based on the Essentials Curriculum for Firefighter I and II. All three main courses, 1152, 1153 and 1154, have been delivered throughout the state for an entire year with very few problems encountered. Any changes that were needed were made and distributed. With the implementation of the new Essentials Curriculum completed, the Curriculum Section has begun the process of updating the Emergency Drivers Training Course, along with the Pump Operations Course. Two committees were formed, one for the driver's course and one for the pump course, to direct and guide the rewriting of these two curriculums to ensure the needs of the fire service in the state were met. The two committees were very successful, and the completed courses are expected to be ready for pilot early in the new fiscal year with field delivery starting soon after. Other major curriculum projects included the updating of our hazardous materials courses, along with rewriting and updating of several industrial courses.

The Fire Academy operates a firefighter certification program that is accredited by the International Fire Service Accreditation Congress. The Fire Academy's program includes eight separate certification areas; Firefighter I, Firefighter II, Driver/Operator, Instructor I, Fire Officer I, ARFF, Fire and Life Safety Educator I and Industrial Fire Brigade. The Curriculum Staff has begun looking at the process for adding the Hazardous Materials Operations Level Course to the certification program.

Note: The number tested included the IFSAC challenge test. This was an increase of 138 percent from last year.

## **Regional Training**

The Fire Academy operates six regional offices, three with full-time staff personnel, and three with part-time staff personnel. The regional offices coordinate and schedule training programs to be conducted at local fire departments or at the regional offices.

This was the busiest year ever at the Fire Academy. There was an increase of 5 percent in courses taught and a 2 percent increase in student attendance. The Fire Academy started 1,008 regional programs, of which: 246 (or 25 percent) were request; 373 (or 38 percent) were training-in-house; and 2 percent were military and industrial in the region. This shows that 65 percent of the programs were delivered when requested. The balance of the programs (or 35 percent) were catalog courses which also were requested by individual fire departments and advertised in the catalog.

The Fire Academy conducted 217 municipal programs as resident programs at the main campus in Columbia, which are broken out as follows:

The Fire Academy completed 1,273 municipal programs for 15,569 students. These municipal programs had 381,663 student contact hours. Dividing hours by 15,659 students equals 24.37 contact hours per student.

Many of the programs taught in the regions also come to the Fire Academy's main campus in Columbia for live fire burns. The Fire Academy's full-time resident staff also teach and assist with most of the haz mat tech, haz mat tech refresher, confined space, rope rescue and terrorism programs conducted in the regions. The Fire Academy sends instructors and equipment to deliver these programs and supports municipal programs in the region by delivering equipment trailers. The Fire Academy made 196 deliveries and traveled 34,917 miles.

# **DIVISION OF LABOR**

State of South Carolina and federal laws are the source of various rights employers and employees have in their employer/employee relationships. LLR, Division of Labor, is one of several state and federal agencies which administers the laws. Occupational safety, payment of wages, child labor, migrant labor and mediation of disputes between unions and businesses all fall under this division. Elevators and amusement rides also are regulated through this division.

# **Office of Occupational Safety and Health**

# **Compliance Section**

The purpose of the state Occupational Safety and Health Act is to assure working men and women a safe and healthful working environment. To see that the objectives of the act are met, the Compliance Section staff of 16 compliance officers and 12 industrial hygienists conducts inspections to ensure compliance with safety standards and initiate enforcement procedures in cases of noncompliance.

During FY 2000-2001, the Compliance Section conducted 2,177 inspections. Safety inspections numbered 1,857 or 85.3 percent of this total. Health inspections numbered 320 or 14.7 percent of total inspections.

A further analysis of compliance activity reveals the following:

- 1,471 planned inspections
- 243 complaint inspections
- 83 accident and fatality investigations, which involved 32 fatalities
- 44 referral inspections
- 95 unprogrammed related inspections
- 108 follow-up inspections
- 97 programmed related inspections
- 36 monitoring inspections

A total of 5,192 violations were cited. The 1,898 other-than-serious violations accounted for 36.6 percent; 3,225 serious violations accounted for 62.1 percent; and 63 repeat violations accounted for 1.2 percent of the total violations; and six willful violations accounted for less than 1 percent of the total violations. The adjusted penalties for these violations amounted to \$900,530. Penalties collected totaled \$681,655.49.

# **Technical Support Section**

Integrated Management Information System

This section has the responsibility to compile, analyze and prepare accurate data concerning safety and health inspections and activities which will assist in the management of the state OSH program. Data collected is used to plan, direct and evaluate the OSH program and to provide objective information on which to base policy decisions.

# **Statistics Section**

Annual Occupational Injuries and Illnesses Survey

The annual Bureau of Labor Statistics (BLS) Survey of Occupational Injuries and Illnesses by Standard Industrial Classification (SIC) and the Census of Fatal Occupational Injuries (CFOI) Program are conducted by the Statistics Section of OSH in cooperation with the U.S. Department of Labor, Bureau of Labor Statistics.

Only a relatively small percentage of the total private sector employers are required to report on the BLS survey. Data collected in this survey is based on uniform recordkeeping requirements, which are mandatory under provisions of both the 1970 Occupational Safety and Health Act and corresponding state laws. The data compiled in this survey is used to provide a management tool for safety engineers and persons interested in measurements of work injuries and illnesses.

During 1999, workers in South Carolina's private industry experienced job-related injuries and illnesses at a rate of 5.7 per 100 full-time employees. Of the 1,488,900 persons employed in South Carolina's private sector workforce in 1999, about one out of every 18 workers suffered a work-related injury or illness. A total of 71,900 occupational injuries and illnesses were reported in South Carolina's private industry workplaces in 1999, a 1.8 percent decrease from 1998. Of the 71,900 recordable cases, an estimated 33,500 cases involved lost workdays. About 95.4 percent of the recordable cases were occupational injuries, and 4.6 percent were illnesses.

BLS survey questionnaires were mailed to 4,648 BLS sample units. A relatively small portion of these were excluded because:

- The employer was no longer in operation;
- They were included in a report for another location;
- Duplicate survey forms were received for the same location; or
- The survey form was not mailed because of an inadequate address.

Mailings, original and follow-up, and telephone calls resulted in 3,621 usable BLS survey questionnaires.

A total of 114 fatal occupational injuries were reported in South Carolina in 2000 under the CFOI Program. Highway accidents were the leading cause of the fatal work injuries in South Carolina accounting for 54 fatal injuries, followed by 21 fatalities, including contact with objects and equipment.

# **Standards Section**

Two public hearings were held during FY 2000-2001 to correct, amend or revise 10 existing OSHA standards. The following telephone calls were addressed:

# South Carolina Occupational Health and Safety Review Board

Under §41-15-600 through §41-15-640, South Carolina Code of Laws, 1976 (as amended), the South Carolina Occupational Health and Safety Review Board is responsible for hearing and deciding contested cases resulting from citations and penalties and determining time periods for abatement of citations issued by the director of LLR.

The board consists of six members, one from each Congressional district.

# **Office of Elevators and Amusement Rides**

The office was created in 1986 to administer the South Carolina Elevator Code and the South Carolina Amusement Ride Safety Code. To ensure compliance with both codes, the licensing staff of 12 inspectors conducts inspections of new and existing elevator facilities, amusement rides and bungee jumps.

# **Elevator Safety Inspections**

Under Chapter 16 of Title 41 of the South Carolina Code of Laws, 1976 (as amended), the Office of Elevators and Amusement Rides administers regulations governing construction, alteration, and installation of new elevators, escalators, dumbwaiters, handicapped lifts and moving walks. It also administers safety standards for existing facilities. All safety standards are national consensus standards in accordance with the American National Standards Institute. The office, and the private inspectors it licenses, inspects elevator facilities and issues operating certificates.

Since registration of elevators and related equipment formally began in July 1986, 7,995 elevators and related equipment have been registered in South Carolina. The highest number of registered facilities were in Richland, Charleston, Greenville and Horry counties. The Office of Elevators and Amusement Rides conducted 6,690 inspections of elevators, escalators, dumbwaiters, handicapped lifts and moving walks. Licensed private inspectors conducted an additional 1,153 inspections. There were 7,843 inspections of elevator-related equipment in FY 2000-01.

Fees for the inspections performed by the Office of Elevators and Amusement Rides are based on the contract price for new elevators under construction or the number of floors served by existing elevators. Fees collected for elevator inspections and permitting are as follows:

## Amusement Ride Safety Inspections

Under Chapter 18 of Title 41 of the South Carolina Code of Laws 1976 (as amended), the Office of Elevators and Amusement Rides administers regulations to guard against injuries in the assembly, disassembly and use of amusement devices at carnivals, fairs and amusement parks. The office, and any special inspector it licenses, inspects amusement devices and issues operating permits. Inspection fees are based on the type of device being inspected and are set by regulation no more than once per year.

During FY 2000-2001, the office issued 703 operating permits for amusement devices and collected \$67,027.50 in inspection fees. Fines for rides that did not comply with state laws totaled \$1,000 this year.

## **Bungee Jumping**

The office began regulating the practice of bungee jumping in July 1994. In FY 2000/01, Myrtle Beach was the only site in the state with a bungee jumping device. The office collected \$450 in inspection fees related to bungee jumping.

# Office of Wages & Child Labor

It is the responsibility of the Office of Wages & Child Labor to enforce the South Carolina Labor Laws regarding Payment of Wages and Child Labor. In 1986, the office was given new responsibilities and authority by passage of Act No. 412, a complete revision of the Payment of Wages Law. As signed by the Governor on April 21, 1986, this Act requires employers to give written notice to employees of certain key terms and conditions of their wages, to pay according to this notice, and to keep records of the payments. LLR is authorized to make inspections, issue warnings and citations, and assess civil penalties for violations of the Act.

In 1989, the office was given new responsibilities by passage of Act No. 209, which is an amendment to state child labor laws as signed by the Governor on June 8, 1989. The amendment allows the agency to make findings concerning employers who engage in any oppressive child labor actions, to issue warnings and citations and assess civil penalties for violations of the Act.

#### Wage-Related Activity Fiscal Year 2000-2001

During fiscal year 2000-2001, 2,483 businesses were investigated; 1,353 warnings were issued for violations of the record-keeping requirements of 41-10-30; and 1,009 citations were issued against employers for failing to pay wages in violation of 41-10-40. Penalties were assessed against employers, collectively, for \$291,050 of which \$105,165 was collected.

# **Office of Labor-Management Mediation**

Under §41-17-10 of the South Carolina, 1976 (as amended), the LLR director is responsible for assisting in the settlement of labor disputes (except railroads and express companies doing business by rail). Through the Office of Labor-Management Mediation, the director investigates industrial disputes, strikes, lockouts and their causes, and tries to help the two sides reach an agreement. When requested by both sides, mediators will act as arbitrators or appoint other arbitrators. In general, the Office of Labor-Management Mediation tries to eliminate the causes of misunderstanding and differences between organized labor and management.

This office also administers the South Carolina Right to Work Law (S.C. Code of Laws, §41-7-10 through §41-7-90), which provides that the rights of workers shall not be denied or abridged based upon their affiliation or non-affiliation with a labor union.

# **Migrant and Seasonal Farm Workers Commission**

The South Carolina Migrant and Seasonal Farm Workers Commission is charged with the responsibility of "examination and supervision of the migrant labor programs in South Carolina, the cooperation with state and federal agencies in improving existing programs, and the coordination of programs to improve the conditions for migrant labor."

The office operates as a clearinghouse by assisting, coordinating and monitoring programs and services provided by public and private organizations.

The office works closely with all agencies addressing the laws pertaining to farmers and migrant and seasonal farm workers in South Carolina.

During FY 2000-2001, the office accomplished the following goals:

- 1. Referred problems and issues that affected migrant and seasonal farm workers to the appropriate state or federal agency. These cases involved housing, hiring practices, emergency assistance, terminations, immigration and referrals.
- 2. Continued to operate a toll-free telephone line with voice mail features so that farm workers and individuals would have access to the office when it is closed or the staff is out of the office.
- 3. Distributed the South Carolina OSHA poster.
- 4. Worked on updating the Services for Workers in South Carolina handbook in English, which includes emergency numbers to help farm workers and growers obtain services when needed. Obtained a grant from the U.S. DOL to publish the handbook. Worked with other agencies and organizations to have the updated handbook translated into Spanish and published.
- 5. Distributed the video package containing two videos, "Steps to Compliance- Educational Tool for Growers in South Carolina" and "Avoiding Immigration Discrimination in Agriculture" to grower's associations, agencies and individuals.
- 6. Collected and distributed clothing, toys, books and toiletries for migrant workers.
- 7. Worked with a non-profit company to obtain a grant for migrant housing. The migrant housing will be constructed in Cherokee County and ready for occupancy in February 2002.
- 8. Spoke to church and civic groups about migrant workers in South Carolina.
- 9. Began work on a task force to assist employers who hire Spanish-speaking workers.
- 10. Worked with an elementary school in Columbia and Big Lots #1012 to send school supplies to a Peace Corp volunteer from Lexington, who is stationed in a small town in Nicaragua.

# South Carolina Migrant and Seasonal Farm Workers Commission

Under South Carolina Code of Laws 46-43-20, 1976 (as amended), the South Carolina Migrant and Seasonal Farm Workers Commission is responsible for "maintaining a continuing consultative examination and supervision of the migrant labor program relating to living conditions; health, housing and public assistance and the coordination of federal, state and local programs relating thereto."

# DIVISION OF PROFESSIONAL AND OCCUPATIONAL LICENSING

Occupational licensure has a long history. Modern day licensure has its roots in workers' guilds, which can be traced back to the 10th century in England. The first modern effort to regulate occupations and professions was Virginia's medical practice act in 1639. In the late 1800s, state licensure activity began in earnest, and by 1900, a majority of the states had licensed attorneys, dentists, pharmacists, physicians and teachers. Between 1900 and 1960, most states licensed an additional 20 occupations and professions including accountants, nurses, real estate brokers, barbers, hairdressers, chiropractors and funeral directors. Today, more than 80 occupations and professions are licensed by one or more states.

Occupational licensing is an exercise of the state's inherent police power to protect the health, safety and welfare of its citizens. State licensure is deemed appropriate when:

- unqualified practice poses a serious risk to a consumer's life, health, safety or economic well-being;
- the public cannot accurately judge a practitioner's qualifications; and
- benefits to the public clearly outweigh potential harmful effects of licensure (such as a decrease in the supply of practitioners).

The absence of these conditions generally indicates that licensure is not justified or that some alternative form of regulation such as registration or certification may be appropriate. Proponents of licensure argue that the purpose of licensure is to raise standards of practice, ensure quality service, and establish accepted codes of ethical behavior. In the last two decades, there has been a growing awareness of licensure's concomitant responsibility to promote continuing professional education and competence and to enforce licensure laws against fraudulent, incompetent and unethical behavior.

On Feb. 1, 1994, Act 181 created the South Carolina Department of Labor, Licensing and Regulation (DLLR). This Act restructured a significant portion of state government by merging the Department of Labor, The State Fire Marshal's Office, the South Carolina Fire Academy and 37 professional and occupational licensing boards to form the new agency. The Professional and Occupational Licensing (POL) Division was established to oversee the administration of the licensing boards. The boards are categorized and separated into three related offices:

- Office of Business and Related Services/Dental, Pharmacy and Long Term Care Administrators (BRS/DPL)
- Office of Property, Environmental, Design and Construction Services (OPEDACS)
- Office of Health and Medically Related Professions (OHMRP)

# OFFICE OF LEGISLATIVE LIAISON

The Legislative Liaison Office (LLO), which falls under the Office of the Director, handles all legislation, internally and externally, that affects the South Carolina Department of Labor, Licensing and Regulation (LLR), including the professional and occupational licensing boards/commissions, the Department of Labor, the South Carolina Fire Academy and the Office of State Fire Marshal. The LLO facilitates the submission of legislation to the General Assembly as well as tracks and monitors all legislation that affects the agency. Since LLR is a cabinet agency, the LLO works closely with the Governor's Office in the initial filing stages and throughout the Legislative Session to have input on all legislation affecting the divisions of the agency.

The agency established a templating process for rewriting the licensing acts for LLR boards and commissions in 1996, Act 453, which was approved and passed by the General Assembly. Since that time, the agency has assisted several boards and commissions in rewriting their statutes. While the agency's input is limited to the structured format and content as it relates to administrative issues, it does not infringe upon the boards' autonomy and responsibility to regulate their respective professions.

During the 2000 Legislative Session, LLR filed and passed 13 regulations, most of which were changes to the boards' existing regulations to make them better comply with their current practice acts. Five practice acts passed this session, and seven more are anticipated to pass in 2001. The other bills filed by LLR that passed in 2000 were statutory changes to current practice acts and labor laws, not total rewrites.
