All revenue collected by the agency is authorized by statute, regulation or proviso, including: S. C. Code Sections 6-9-90, 23-9-45, 23-9-560, 23-51-40(E), 40-1-50, 40-1-110, 40-1-180, 40-3-255, 40-22-245, 40-57-70, 41-16-140; S.C. Code of Regulations R.10-1 et al.; and Provisos 81.1, 81.4, and 81.11 of the FY16-17 Appropriations Bill. Revenue is used for the general operations of the agency, including personnel, employer contributions, operating expenses, equipment and maintenance.

Proviso 81.3 directs LLR to transfer an amount equal to 10% of the expenditures in Program II.F. Professional and Occupational Licensing and all revenues above expenditures from the Contractor's Licensing Board to the General Fund. In FY17, the amount remitted to the General Fund was \$2,048,281.79.
