- 1) Senior Engineering Students**—File Short Form with Dept. Head at The Citadel or Dean at Clemson University and the University of South Carolina. (Filing schedules will be posted by institution.)
 - 2) Senior Engineering Technology Students**—File Short Form with Dean, SC State University. (Filing schedules will be posted by institution.)
 - 3) EAC/ABET Engineering Graduates**—File Short Form with Board Office. Transcripts may be sent to Board by Registrar or Applicant (transcripts must arrive in ***an envelope sealed and stamped by the Registrar***). File by **DECEMBER 15th** for Spring Exam; File by **JUNE 15th** for Fall Exam.
 - 4) TAC/ABET Engineering Technology Graduates**—File Short Form with Board Office. Transcripts may be sent to Board by Registrar or Applicant (transcripts must arrive in ***an envelope sealed and stamped by the Registrar***). File by **DECEMBER 15th** for Spring Exam; File by **JUNE 15th** for Fall Exam.
 - 5) Non-EAC/ABET Engineering Graduates**—File Short Form with Board Office. Transcripts may be sent by Registrar or applicant to the Board (transcripts must arrive in ***an envelope sealed and stamped by the Registrar***) for evaluation and approval before applicant can be admitted to exams - additional fee required for education evaluation. File by **DECEMBER 15th** for Spring Exam; File by **JUNE 15th** for Fall Exam.
 - 6) Students in Graduate Programs**—The Board will not admit anyone to sit for the Fundamentals of Engineering Examination currently enrolled in a graduate program that does not have an approved undergraduate degree. An application may be filed after receiving the Master of Engineering or Master of Science in Engineering. An applicant must have transcripts sent by the Registrar to the Board for evaluation – additional fee required for education evaluation. (For information regarding education evaluation, refer to “Qualifying Education”). Information may also be obtained by calling the Board Office: (803) 896-4422. File by **DECEMBER 15th** for Spring Exam; file by **JUNE 15th** for Fall Exam.
