## Instructions for Online Application for Engineer-in-Training (EIT) Certification

## **ATTENTION:**

The online application should be completed if you have met the educational requirements for certification, have passed the Fundamentals of Engineering (FE) Examination, <u>AND</u> you designated South Carolina as your FE exam state.

## Education Requirement

Official transcripts must be sent directly to the Board office. It is the responsibility of the applicant to obtain the necessary documents. All transcripts from colleges and universities in the United States showing courses taken, degree(s) awarded, and date(s) of degree(s) must arrive at the Board Office in an envelope sealed and stamped by the Registrar. Electronic transcripts are accepted from the institution and may be emailed directly to the Board at <u>Contact.EngLS@llr.sc.gov</u>.

Applicants must hold a baccalaureate degree in an EAC/ABET accredited engineering curriculum or an EAC/ABET master's degree. For applicants with an EAC/ABET master's degree who do not have an approved undergraduate degree, the master's degree in this category will be accepted as the qualifying engineering degree. The Board will recognize the degrees of Master of Engineering or Master of Science in engineering in a program accredited by EAC/ABET at either the baccalaureate or master's level as fulfilling the education requirements per SC Code of Regulations, 49-200.

Applicants holding foreign engineering degrees or non-EAC accredited degrees must have the education evaluated by an acceptable education evaluation service prior to approval as an EIT. Official transcripts must be forwarded to the Board Office. Education evaluations may be conducted by NCEES (<u>www.ncees.org</u>) or the SC Board Independent Consultant. NCEES Credential Evaluations are accepted by other NCEES member board jurisdictions. The SC Board does *not* guarantee evaluations conducted by the Board Consultant will be accepted by other jurisdictions. Upon submittal of the application and receipt of the transcripts, you will receive additional information regarding the education evaluation.

## Fee

There is NO application fee for EIT Certification.

- Verification of Lawful Presence Form (Download this form and have it notarized)
- Notarized Affidavit of Attestation
- Copy of Social Security Card

I swear and attest the information contained herein is true and correct to the best of my knowledge. I understand that under South Carolina law, providing false information is grounds for denial, suspension, or revocation of a license, certificate, registration or permit.

#### INSTRUCTION SHEET FOR COMPLETING AFFIDAVIT OF ELIGIBILITY

#### CHECK box 1:

If you are a United States Citizen by birth or naturalization

#### CHECK box 2:

If you are a Legal Permanent Resident and you are not a U.S. Citizen, but are residing in the U.S. under legally recognized and lawfully recorded permanent residence as an immigrant. **PROVIDE A COPY OF ALL IMMIGRATION DOCUMENTS.** 

#### CHECK box 3:

If you are a Qualified Alien. You are a Qualified Alien if you are:

An alien who is lawfully admitted for residence under the INA.

An alien who is granted asylum under Section 208 of the INA.

A refugee who is admitted to the United States under Section 207 of the INA.

An alien who is paroled into the United States under Section 212(d)(5) of the INA for a period of at least 1 year. An alien whose deportation is being withheld under Section 243(h) of the INA (as in effect prior to April 1, 1997) or whose removal has been withheld under Section 241(b)(3).

An alien who is granted conditional entry pursuant to Section 203(a)(7) of the INA as in effect prior to April 1, 1980.

An alien who is a Cuban/Haitian Entrant as defined by Section 501(e) of the Refugee Education Assistance Act of 1980.

An alien who has been battered or subjected to extreme cruelty, or whose child or parent has been battered or subject to extreme cruelty.
